The 2022 Puntland Highway Authority's Annual Report summarizes the Authority's tremendous achievements in building capacity of departments and establishing systems for the organization. It also showcases the prudent management of projects and utilization of the allocated project funds in the last 12 months. The projects and programs implemented during the year are aligned with the 2022-2023 Strategic Plan. The Strategic Plan defines key areas along which the Authority focused on to deliver on its mandate. 1.0 INTRODUCTION

BACKGROUND INFORMATION

The 2022 Annual Report presents an overview of the operations of the Puntland Highway Authority and an assessment of the degree to which performance targets have been achieved. The Authority's financial accounts and reports of the Auditor are also attached. The Annual Report assesses the financial and technical capacity of the Authority to deliver its mandate given the road network condition. The report has been developed to promote information sharing with the stakeholders and foster collaboration in the delivery of quality and adequate services by the Authority.

PHA remained focused on its mission of supervising and managing national road networks by undertaking various activities aimed at ensuring the availability of quality and adequate roads.

The Authority implemented its mandate along the following key result areas as defined in the Strategic Plan: Development of roads and enhancement of network capacity and quality; securing and preservation of road assets; environment and social sustainability; enhancement of institutional framework and capacity; effective resource mobilization; and leadership and governance.

Mandate of Puntland Highway Authority

Formulating policies for supporting the development of highways in Puntland including Promotion of the rehabilitation and reconstruction of existing roads, and their related services in the North- East area and controlling and supervising local, foreign and jointventure companies within the terms of concluded contracts. The Authority is also mandated to regulate and register all contractors, while at the same time doing everything possible to encourage the local bidders to be more competitive.

Formulation of Plans and designs and ensure development, construction, rehabilitation, reconstruction and maintenance of roads in Puntland.

• Management of Puntland national roads and road right of way including land reserves and access to road site developments


• Implementation of road policies and regulations concerning Puntland national roads, including Puntland Axle load control act

- 7. Member of the Puntland Chamber of Commerce




PHA GOVERNANCE CHART

Figure 1.1: Puntland Road Types







Figure 2. This chart Indicates overall performance progress of PHA's entire 147 strategic plan activities, these details present the number and percentage of achieved activities, progress tasks, and not achieved activities for PHA's total planned activities.





2.0 SUSTAINABLE ROAD REHABILITATION PROJECTS REPORT

2.1 Road Projects Management Capacity Development

Introduction

This report is snapshot about completed fourteen (14) road rehabilitation projects that have been implemented in different sections along the main road that links Garowe to Galkacyo, Garowe to Las'ano and Garowe to Bosaso. This road rehabilitation and reconstruction initiative was entirely funded from Puntland government revenue and was implemented by competent local private contractors under the technical supervision of PHA.

The program commenced on 19th August 2021 and the first phase was completed on 26th July 2022.

Context

Even though Puntland state has enjoyed political stability and peaceful with functioning administration, yet subsequent previous administrations did not pay much attention on the deteriorating roads infrastructures in Puntland regions. Bosaso-Galkayo road has endured very poor condition despite being economic artery of Somalia in general, and particularly for Puntland state.

The poor conditions of this road can be ascribed to the age of the road infrastructure, a severe lack of maintenance for decades, and overloading due to insufficient axle-load control. The main problem leading to this severe lack of maintenance of road assets is lack of public sector support for the road networks. This widely damaged road asset has constrained economic growth and social mobility due to high transportation costs and difficult or no access to markets and social services.

The status of the road condition of Galkayo-Bosaso was in emergency level hazard due to combination of factors over aging of the road with tear and wear caused by over loaded vehicle weight, tire wear, unregulated vehicle speed, harsh climate as well as limited maintenance resulting cracks, potholes, rusted pipe culverts, deteriorated condition of bridges, washed embarkments, overgrown vegetation and deteriorated side drain canals.

Project Description

Given the importance of road networks in regard to people movement and promotion of economic growth. Puntland current administration led by H, E. Said Abdullahi Deni has prioritized for rehabilitation and construction of the roads to improve road transport in Puntland.

The road Rehabilitation and Reconstruction Program aims to improve management of the road infrastructure at the state level and improve transport connectivity for road users in

the targeted sections of Bosaso -Galkayo road for rehabilitation while reinforcing the capacities of Puntland state institutions that manage road infrastructure.

The rehabilitation, reconstruction and construction of Galkayo-Boaso road will improve access to Bosaso port and linkages to other regions both with in Puntland and rest of Somalia. Consequently, the government allocated \$11 million, for this program, the first phase 1 which have been accomplished in 2021 and 20222 through government funding and implemented by local qualified contractor companies under the technical supervision of PHA.

The completed PHASE I activities were maintenance and construction of Galkayo- Garowe main road, Garowe- Laascaanood section and Garowe- Bossaso, addressing the emergency conditions of the road and restoring it to relatively operability normal condition.

The maintenance works comprised; Improving the existing drainage structures and system, repairing of broken road embankments, rehabilitation of 10 bridges, constructing of 82 new concrete culverts, restoration of 78 existing pipe culverts, filling of potholes and constructing and repairing of 9 km surface dressing of carriageway and shoulders and construction of 14km of hot mixed asphalt. In phase 1, the project targeted 8 sections in different parts of Galkayo-Bosaso Road selected on the basis of severity of the damage which were in emergency level.

Figure 2. 2: Road Rehabilitation Types







2.2 Projects Management Department

Introduction

The Projects Management department is divided into two sections, which include the Supervision & Projects Management, and Special Projects Sections.

Department Functions and roles

The project management department is responsible for planning and overseeing projects to ensure they are completed in a timely and within budget. The department is also responsible for Managing construction projects undertaken by PHA, by assigning a project manager and project team to manage aspects such as schedule, cost, scope, quality, risk & contract management and also assists Providing supervision and project management support to projects implemented by external partners e.g. contractors, and international NGOs.

The department is also tasked with Developing and adopting project management manuals and documents based on international best practices, Developing and implementing annual/quarterly action plans based on the strategic plan tasks assigned to the section, developing mechanisms for realizing and managing special projects including Public Private Partnership (3P) Projects e.g. Build-Operate-Transfer (BOQ) projects, and crowdfunded projects in addition to Designing and implementing a road construction management system for the execution of planned road construction works.



Department Activities Highlights

4.1 Garowe- Birtadheer 8 Bridges

On 18th September, 2022, the government of Puntland has contracted Kebarco Construction Company the implementation of eight construction pipe culverts from Garowe to Birtadheer under agreement reference no. KDH/006.

The government of Puntland Has financed to the Project in a cost of \$120,000 and planned timed to the whole project activities in three months.



4.2 Qiyaadsame 1 Bridge

The Puntland Government has tasked Albashid Construction Company to undertake the assessment of the damage, design and finally contracted rehabilition works of four bridges in Qayaadsame under agreement reference no KDH/005 dated on 17th September, 2021 and KDH/10 dated on 10th March 2022.

The President of Puntland, H.E. Said Abdullahi Deni has laid the foundation stone of the bridge and financed in a budget of \$784,081.



4.3 Garowe- Falaydhyaale road

Under agreement reference no KDH/007 the Government of Puntland of Somalia has contracted Shire Construction Company the implementation of surface dressing and pothole repair works for the Garowe - Falayryale road section in Falayryale village area, Sool region.

Shire Construction Company has been completed the implementation of the project in a cost of \$329,926,000 within four (4) months of period.



4.4 Laacdheere- Rabaable Road

On January 01, 2022, PHA signed a contract with KEBARCO for the reconstruction and rehabilitation of a Laacdheere to Rabaable road in a cost of \$2,100,000. The road is paved for its entire length and traverses three disricts of Garowe, Burtinle and Galkacyo. The total length of the road is 14km which locates Garowe - Galkacyo corridor section.



4.5 Burtinle- Xaarxaar Raod

This agreement (Contract) was made on 6th June 2022 between the Puntland Government of Somalia represented the by Puntland Highway Authority (PHA) "hereinafter referred to as "the Employer" on one-part and Isxilqaan Construction Company. In the cost\$1,547,407.30



4.6 Middigar Road

Under agreement reference no KDH/004 the Government of Puntland of Somalia has contracted Albashid Construction Company the implementation of re-construction and rehabilitation works for the Middigar road section in Sinujif village area, Nugal region.

Middigar road stretches around nine-kilometer-long sealed road starting the east of the Sinujif village, 754 meters off the Madigar hotel (Refer chainage 0+000 at Culvert No-1) and ends near Qal-Qalooc water well (chainage 9+000 at Culvert No-44). The road is part of the national artery road for the state of Puntland connecting the port and commercial city of Bossaso to main cities of Puntland including the capital city of Garowe and rest of the somali states and regions. The road was built by the Italian contractor between the 1988 - 1989 and since after the over 30 years on it is usage the road did not receive the routine maintenance or reconstruction and sealing surface



4.7 Hajikhayr Road

On 30th November, 2021, the Ministry of Finance of Puntland signed a contract with Albashid Construction Company under agreement reference no KDH/008 and KDH/09 for Hajikhayr road rehabilitation. The MoF has financed to the Hajikhayr road in a cost of \$305,919.



4.8 Dalsan Road

On August 25, 2022, PHA signed a contract with ALBASHID for the reconstruction and rehabilitation of a Dalsan road in a cost of \$299,500.00.



4.9 Lafagoroyo Road Rehabilitation Project

On August 14, 2022, PHA signed a contract with National Engineering & Construction Corporation for the reconstruction and rehabilitation of a Lafagoroyo road in a cost of \$680,000.00



4.10 Kalabayr 45 Culverts Project

The Government of Puntland, represented by the Ministry of Finance, have signed contract No. KDH/003 with Eldahir-Erigabo Road Committee on 18th of September 2021 to carry out the reconstruction or rehabilitation works for 45 pipe culverts from Bossaso to Kalabeyr Village of Bari region. The total length of road to be covered under this agreement is 48 km of the Trunk Road connecting the Port and Commercial City of Bossaso passing through many major cities in Puntland including Garowe, the capital of the Federal State of Puntland. The Ministry of Finance of Puntland has finance to the project in a budget of \$863,500 from government fund.



4.11 Xarfo- Burtinle Road

This agreement (Contract) between the Puntland Government of Somalia represented the by Puntland Highway Authority (PHA) "hereinafter referred to as "the Employer" on one-part and Isxilqaan Construction Company. In the cost\$1,800,000.00



4.12 Qayaadsame 3 & 4 Bridges

The Puntland Government has tasked Albashid Construction Company to undertake the assessment of the damage, design and finally contracted rehabilitation works of four bridges in Qayaadsame on the cost of \$ 114,081.00.



4.13 Haji-khayr two road

PHA signed a contract with ALBASHID for the reconstruction and rehabilitation of a Hajikhayr two road in a cost of \$ 85,919.00



4.14 Bursalax - Galkacyo road

PHA implemented the road project of bursalah with 26km in cost of \$520,000 and together PHA and Bursalah Community paid the cost of this project



4.15 Sheerbi - Dhahar - Xingalool road

The President of the Puntland State, Said Abdullahi Deni, recently laid the foundation stone for the construction of the 53km road connecting Sheerbi, Dhahar and Xingalool. The road construction is in progress.

Socio-Economic Impact

Maintenance costs: Road users, particularly drivers and transport business owners have shown their appreciation of improved road transport as result of the rehabilitation projects funded by the government and implemented by competent professional private contractors.

Ahmed Jama is truck owner who frequently travels on Bosaso-Galkayo road, Mr Jama transports goods from Bosaso port to central regions in Somalia, he says before, it was very difficult to afford maintenance costs because every now and then there was problem related with damage because of extreme bad conditions of the road, so there was need to purchase spare parts to replace malfunctioning or damaged parts of the truck. We incurred roughly \$500 monthly for maintenance costs.

Sometimes, I used to ask myself if it was worth to stay in the business because maintenance expenses were so discouraging, but now, I feel relived thanks to the road rehabilitation and road transport improved. Maintenance expenses had significantly reduced from \$500 to only \$150 per month.

Economic Development:

Bosaso-Galkayo main tarmac road connects Bosaso port to Puntland and central regions, facilitating export of livestock and trade business as well movement of people. The rehabilitation of this strategic road has significantly contributed to economic dynamics of Puntland state through increased traffic and promoted trading activities. Business groups, particularly those in the transport sector have expressed their appreciations for the improvement of the road. Ali Jama who is owner of truck says, he feels confidence to continue transport business and anticipates it will sustain with profits because of the improved road.

The program has also indirect positive impact on the sustainability of government revenue. According to government officials, before the intervention, government revenue was on the decline from decreased transport traffic and trade activities constrained by the poor conditions of the road infrastructure. However, the rehabilitation of the road has improved the condition of the transport and subsequently increased trade activities and public revenue.

Institutional capacity strengthening

To ensure sustainable good management of road networks and maintenance of such valuable assets, it is important to strengthen the functional capacity of Puntland High Way Authority (PHA) which is government authority mandated for the development, rehabilitation and management of roads and highway networks in Puntland State of Somalia.

In recognition of this crucial issue, president Said Abdullahi Deni has appointed new leadership for PHA with instructions to strengthen PHA institutional capacity and its technical functionalities up to the challenge of the task.

Since then, the PHA has taken the following changes to enhance institutional capacity:

- Improved governance under the leadership of corporate board of directors, providing oversight and policy direction of PHA
- Enhanced financial management system by adopting standard accountability procedures, reducing financial management risks. Internal auditing and other management controls are routinely conducted to ensure that financial procedures and policies are strictly adhered.
- Strengthened Technical engineering capacity through training of engineers to upgrade their skills.
- Increased quality control capacity by increasing monitoring and evaluation expertise through hands on exercises.
- Developed strategic plan and strategic communication plan to guide future projects and organizational operations.
- Improved coordination and collaboration among stake holders including private

contractors, and line ministries related with program.

- Rehabilitated office buildings in the HQ to create conducive working environment for staff
- Rehabilitated laboratory space buildings in Garowe and Burtinle to strengthen functional capacity of quality assurance.

Challenges and lessons learned

In spite of some challenges during implementation, fortunately, all projects were generally successfully accomplished. Below are some of the challenges encountered during the implementation phase.

- Delays of payment due to fund constraints and logistical challenges caused delays in activity implementation, falling behind planned deadlines, leading to rescheduling and adjustments.
- Some survey activities could not be performed on time due to malfunctions of survey instruments
- Lack of traffic management causing road users to drive in to construction sites. Traffic Interruptions and Vehicles Entering Before Finished
- The fuel prices in the global market have risen in 2021 due to war in Ukraine and that have had a negative impact on the costs of building the roads.
- Rainy weather, and climate change has had a negative impact on road construction works.
- Limited experience of local contracts and their employees in road construction.

Despite the above-mentioned challenges, PHA took efforts to address the challenges and coordinated with all stake holders to work to gather for quality assurance.

In addition, PHA prepared all necessary procurement documentations including technical proposal for the next phase projects, and bidding process in which local Contractors will be selected on transparent competitive process.

Introduction

The Office of the Chief Executive Officer is central in coordinating daily operations of the agency. The units under the CEO's include Internal Audit Unit, The General Secretary, Communication and Public Relations Unit, Legal Affairs Unit and Records and Archives Management Section.

Department Functions and roles

The office of the CEO is responsible for Coordinating the preparation and implementation of the three (3) year strategic plan and budget for the Authority, Planning, designing, development, construction, rehabilitation, reconstruction and maintenance of roads which includes bridges, culverts, siphons, Irish crossings and any other structure considered necessary for road network structures, Planning developing standards, codes and specifications for the national and local authorities' roads, including constructing, upgrading, rehabilitating and maintaining roads under its control through force account or through contractors

The unit is also responsible for the Management of engineering and technical work relating to planning, designing, construction and rehabilitation of roads and highways, Promoting and providing security and protection of national trunk road reserves and assets in Puntland, Promoting the use of local resources and ensuring material quality and quantity in road construction and maintenance and general Coordination of the preparation and implementation of a comprehensive monitoring and evaluation system and tools for the PHA amongst other roles as stipulated in the functions department manual.



3. Bi-weekly meeting of the CEO and department heads

The agency held regular bi-weekly meetings between the CEO and departmental directors in the last three months of March, April, and May.



4. Rehabilitation of PHA's Headquarter Offices

The various departments offices of the agency were renovated, including working offices, labs, indoor and outdoor fences, reforestation, and the ablution block. This rehabilitation has enhanced the beautification and appearance of the PHA's building headquarters.



5. Office equipment and furniture

The agency equipped offices in each department and purchased office supply & equipment for staff, including chairs, tables, and cabinets.



6. PHA's Lab Renovation

The agency has revamped the old laboratory of the agency by effecting necessary renovations. The laboratory was then equipped with modern laboratory equipment to improve functionality and reliability.



7.The CEO supervised the Jalab-Xarfo main road.

On March 7th, the Chief Executive Officer of PHA supervised the construction of 65km (Jalab-Xarfo) road. A total of \$6,100,000 was spent on the project. 70% of the project was funded by the EU while 30% of the project was funded by Puntland's current government.

2. The C E O of the PHA supervised the site, the equipment and lab center in the Burtinle district.

On March 5, 2020, the executive director of the PHA supervised the site of equipment and lab center in the Puntland district.

The chairman also received a report from the site staff which provides an overview of the information related to the work, situation, traffic conditions and challenges.





Department Functions and roles

The department is responsible for the following; Defining a framework for the development of an information system for road management, Designing and implementing data collection system for the gathering of data on the condition of the road network Design and implement design standards and methods for detailed engineering design at the project level. This includes in particular standards for pavement evaluation and design.

Other responsibilities includes Carrying out field investigations and laboratory tests for the inventory and development of soil and construction materials needed for road construction and maintenance programs and Overseeing the functioning of a pavement evaluation unit (PEU) regarding the annual surveys of pavement roughness and other testing programs for pavement design.

The department assist in Developing environmental assessment guidelines with particular reference to road maintenance and construction in collaboration with the regional environmental protection agency and also in Identifying potential adverse ecological impacts which are normally associated with road maintenance and construction, and recommending measures which would mitigate these adverse impacts.



It's also in charge of Supervision of the layout/design/construction/operation of parking facilities, Assessment and monitoring of the traffic-related administrative plans to enhance road construction, rehabilitation, and maintenance and Provision for future highway needs by undertaking a comprehensive and integrated program of the traffic demand, engineering factors, socio-economic factors, and environmental issues

Other roles include Preparation and implementation of a comprehensive monitoring and evaluation system and tools for the Department, Preparation and implementation of the capacity development for all staff based on the needs assessment and in line with Puntland Civil Service Commission (PCSC) guidelines and requirements and Preparation of the annual financial estimates in consultation with the heads of sections.



1. Improving Maintenance

Management System

The entire Maintenance Management Department has been developed by training Engineers working in the Projects and Maintenance departments. The most important trainings facilitated include 'Pavement Maintenance Management and Pavement Condition Index (PCI), the document preparation process and the Quality Assurance process.




1. An assessment survey for damages on the main road (Garowe - Bosaso).

In March 2022, a team of Engineers, composed of five led by the Lead Engineer, undertook a survey on damages on the main road between Garowe - Bosaso, including embankments, bridges, potholes, closed bridges, and culverts. The survey was divided into two; A, Garowe - Qardho and

B, Bosaso - Qardho.

This assessment survey has taken two weeks and it will be the baseline for the rehabilitation plan for the road by 2022.



2. Road Rehabilitation: Part1 Potholes Repairs

The agency rehabilitated the potholes between Bosaso and Qardho, PHA also deployed a team to carry out the rehabilitation work.

Previously, the team rehabilitated the potholes on the road between Sheerbi and Waciye districts.



3. Re-opening closed bridges and culverts

In May 2022, the rehabilitation team re-opened the closed bridges and culverts between Qardho and Bosaso.

The rehabilitation work focused on reopening closed culverts and embankments of the main tarmac road, which had been blocked by overgrown vegetation, sand and stones.

This work aimed at clearing the tarmac road, which may have deteriorated if not addressed immediately. The work of cleaning bridges and water channels/culverts of project Phase 2 will be addressed according to the situation of the road between Qardho and Garowe.

4. The assessment survey on the status of the bridges on the Garowe - Bosaso main road

The PHA's engineers undertook an assessment on May 17th, for one week. The purpose of the assessment was to evaluate the current status of the bridges on the Garowe - Bosaso road. This assessment found the road conditions and bridges that needed to be addressed and repaired immediately.



3. Harfa - Baadweyn road

maintenance

The agency has repaired the road between Harfo District and Badaweyn settlement in Mudug region for a distance of 17km. The Puntland Highway Authority Maintenance Department has carried out the project to repair potholes on the road. Name of the project: Rabaable-Birtadheer Region: Nugal Agency: PHA



4. Enhancing of the Institutional Engineering Department

Strategic Objective 11: To Improve Puntland Roads Safety and Develop Rules and Regulations of Road Safety.



Activities of the Department:

The situation of the Karindhiig steep in Dangorayo District was assessed, the assessment finds it dangerous and more prone to accidents that has led to loss of lives, The assessment report for this was made.

The department conducted a three-day survey of the rough roads of jid-moxor and jidbanaan in Ufayn District, to assess the possibility of a road diversion to the upper side of the Cal-Miskaad mountain area.

The department has created awareness about the damage caused by the over cargo carried by the trucks, and it has been broadcasted in the media outlets.

The department has constructed at Karin-dhiig road sign boards which indicate the dangers of the road and its condition, and has also constructed hums on the road to reduce the speed of vehicles traveling on the road.

The department has prepared a report on the dangers of heavy cargo carried by trucks, which poses a serious threat to the longevity of the road.

The department is engaged in establishing the boundaries of the land intended for the establishment of the heavy cargo monitoring center in Garowe District.

The department has been tasked with banning the use of plastic pieces which is attached tailgates on trucks that cause potholes and shoulder erosions of the road, and the department has also trained the traffic police to enforce the ban.

The department has conducted a survey on the condition of the curves and steeps on the highway that connects the commercial city of Bosaso with the Puntland capital of Garowe, in order to prepare the necessary road sign board.

The department has assessed the cost of modern road signs that will be printed and imported from Turkey.

5.0 CHALLENGES & RECOMMENDATIONS

The PHA family has made significant progress in advancing the four goals its strategic plan. Through collective effort, more than **62**, (**35**%) of its activities have been achieved, **63**, (**36**%) are in progress with significant progress status, **51**, (**29**%) of our planned activities are not yet achieved and we hope to be achieved in the remaining two years of the plan.

Having established a formal process of monitoring and evaluation, in the next two years the implementation of this plan and commitment of the institution to continuous growth of the institution all its objectives can be achieved fulfilling the mission and vision of Puntland Highway Authority.

Challenges:

During data collection for the preparation of this report, there were several challenges faced by different departments/units summarized below;

- 1. Financial constraint: this is common challenge, strategic implementation however is expensive, requires significant resources to be successful in strategic planning and implementation.
- **2. Time constraint:** this limitation states some of non-achieved activities needs period of time to their implementations.
- **3. Performance issue:** high performance is essential for accomplishing the overarching goals, less performance can cause to be the downfall of goal implementation.
- **4. Management issue:** due to the management, some of activities are not given priority for implementation by the year 2022.
- **5. Resistance to Change:** The resistance can undermine the success of implementation of objectives, as employees contribute half-heartedly to change efforts.
- 6. Lack of Office & adequate for the Road Safety Department

Recommendations:

With every passing day, the PHA demonstrates its capacity for change, its open-minded willingness to try new approaches, break through barriers, and upend Puntland Road development. Despite challenges from within and without, it is certain that progress will continue and that, ultimately, PHA will push forward sustainable development strategy into various areas,

The following are the recommendations:

- ✓ The budgeting process should be linked to the strategic plan, to ensure adequate financing of strategic activities.
- ✓ All employees of the organization should understand the organizational strategic plans and contribute towards realization of organization's strategic goals.
- ✓ Having adequate motivation and training of qualified personnel encourages staff to deliver on organization's strategic goals.
- ✓ An effective strategy requires cross-departmental and cross-functional feedback from across the organization. However, to avoid lack of performance, everyone needs to own the final responsibility execution of the strategy.
- ✓ Follow up and review are essential after executing a strategy, it is important to review the results.
- ✓ Staff should shift the focus from "an employee working inside a department" to "an employee working towards PHA's strategic goal as part of a strategic team."
